WHEREAS, the Annual Budget for Plumsted Township FD No. 1 (the 'Fire District') for the fiscal year beginning January 1, 2024 and ending December 31, 2024 has been presented before the Board of Commissioners of the Fire District at its open public meeting of December 4, 2023; and

WHEREAS, the budget as introduced is in compliance with the Property Tax Levy Cap Law (N.J.S.A. 40A:4-45.44 et seq.); and

WHEREAS, the Annual Budget as introduced reflects Total Revenues of \$4,154,114.61 which includes an amount to be raised by taxation of \$2,717,741.31 and Total Appropriations of \$4,154,114.61; and

WHEREAS, the amount to be raised by taxation to support the district budget shall be the amount to be certified to the assessor of the municipality to be assessed against the taxable property in the district, pursuant to N.J.S.A. 40A:14-79. Such amount shall be equal to the amount of the total appropriations set forth in the budget minus the total amount surplus and miscellaneous revenues set forth in the budget; and

WHEREAS, in calculating the amount to be raised by taxation, the Fire District has taken into account the assessed valuation of taxable property in the Fire District;

NOW, THEREFORE BE IT RESOLVED, by the Board of Commissioners of the Fire District, at an open public meeting held on December 4, 2023 that the Annual Budget, including all related schedules, of the Fire District for the fiscal year beginning January 1, 2024 and ending December 31, 2024 is hereby approved; and

BE IT FURTHER RESOLVED, that the anticipated revenues as reflected in the Annual Budget are of sufficient amount to meet all proposed expenditures/expenses and all covenants, terms and provisions as stipulated in the Fire District's outstanding debt obligations, capital lease arrangements, service contracts, and other pledged agreements; and

BE IT FURTHER RESOLVED, that the Board of Commissioners of the Fire District will consider the Annual Budget for adoption on January 2, 2024.

The overall budget increased \$1.4M (51.5%) due to the purchase of a pumper truck, not to exceed \$1.1M, with fund balance cash.

**3. Explain any variances over +/-10% for each line item.** Attach in FAST any supporting documentation that will help to explain the reason for the increase/decrease in the budgeted line item.

Unrestricted fund balance increase of \$485,133 and Restricted fund balance increase of \$650,000 to fund the purchase of a pumper truck for \$1.1M and offset \$35,133 of operating expenses. EMS: Standby revenue increased \$10k (100%), EMS Other revenue increased \$850 (567%) and Medical Billing Collections decreased \$1k (50%) based on current year actual. American Rescue Plan Grant decreased \$27k (100%) due to the end of the grant period. UFSA: Decreases in Permits \$3k (27%), Inspections \$2,500 (45%), LEA Rebate \$7k (37%) due to no longer serving North Hanover Twp. Admin: Insurance increase \$10k (30%) based on quote, Increase in Office supplies \$1k (20%) based on current year actual. Lawsuit settlement decrease of \$40k (100%) due to nonrecurring expense, Increase of \$5k (100%) for grant writer to apply for more grants to offset expenses. Operations: Salaries increased \$111k (11%) due to contractual increases, Fringe Benefits decreased \$70K (8.8%) due to 3 employees opting out of state health insurance plan, and other contract renegotiations. Fire Marshall: Increase in Office supplies \$1k (100%) based on current year actual. EMS: R&M Bldg \$2k increase (100%) for building expenses not covered by Township, Operating Lease decreased \$32k (47%) due to the end of lease in 2023. Increase for EMS equipment \$26k Compression device, \$5,100 Defibrillators, \$2,100 Suction units, Increases in Medical supplies \$1,500 (18%), Telephone/WiFi \$1,830 (133.6%) and Office supplies \$200 (20%) based on current year actual, Training and Education increase \$1,500 (43%) for new and current employees to maintain required certifications. FIRE: Increase in hydrant rentals \$6,640 (15.3%) due to additional hydrants, Increase in Gear & PPE of \$8k (25%) due to increased costs by manufacturer, Increase in tools/supplies for apparatus maintenance \$5k (50%) based on higher cost to maintain aging apparatus. RADIOS decreased \$5,730 (35%) due to needing only 2 radios, SCBA increased \$14k (52%) due to need to replace 25 expired bottles, Extrication tools increased \$17,817 (131%) to replace aging equipment. Salaries offset with Revenue decreased \$12,500 (25%) based on anticipated revenue. Capital appropriations increased \$1,350,000 (675%) due to purchased of pumper tanker for \$1.1M and increase in reserve for future of \$250k

The amount to be raised by taxation increased 12.75% (307,250) and the District is utilizing \$485,133 unrestricted and \$650,000 restricted fund balances to offset the tax burden. The District is in compliance with the Property Tax Levy Cap.
