WHEREAS, the budget as introduced is in compliance with the Property Tax Levy Cap Law (N.J.S.A. 40A:4-45.44 et seq.); and

WHEREAS, the Annual Budget as introduced reflects Total Revenues of \$3,715,059.92 which includes an amount to be raised by taxation of \$3,287,569.92 and Total Appropriations of \$3,715,059.92; and

WHEREAS, the amount to be raised by taxation to support the district budget shall be the amount to be certified to the assessor of the municipality to be assessed against the taxable property in the district, pursuant to N.J.S.A. 40A:14-79. Such amount shall be equal to the amount of the total appropriations set forth in the budget minus the total amount surplus and miscellaneous revenues set forth in the budget; and

WHEREAS, in calculating the amount to be raised by taxation, the Fire District has taken into account the assessed valuation of taxable property in the Fire District;

NOW, THEREFORE BE IT RESOLVED, by the Board of Commissioners of the Fire District, at an open public meeting held on December 15, 2025 that the Annual Budget, including all related schedules, of the Fire District for the fiscal year beginning January 1, 2026 and ending December 31, 2026 is hereby approved; and

BE IT FURTHER RESOLVED, that the anticipated revenues as reflected in the Annual Budget are of sufficient amount to meet all proposed expenditures/expenses and all covenants, terms and provisions as stipulated in the Fire District's outstanding debt obligations, capital lease arrangements, service contracts, and other pledged agreements; and

BE IT FURTHER RESOLVED, that the Board of Commissioners of the Fire District will consider the Annual Budget for adoption on January 19, 2026.

The overall budget increased \$416k (12.5%) mostly due to an increase in capital appropriations.

REVENUE: Unrestricted fund balance utilized decrease of \$91k (48%) in effort to build unrestricted balance. New revenue item of \$50k for the sale of a tanker truck - the truck was replaced by the pumper truck approved by voters 11/6/23 which was delivered and placed in service in November 2025. Medical Billing decrease of \$25k (10%) and EMS other Revenue decreased \$750 (75%) based on actual, Medical billing collections reduced to -0- as it is no longer segregated in the accounting software. Fire Watch & Standby reduced \$8k (62%) due to a decrease in fire pit events at a local business. EXPENSES: Accounting fees increased \$18k (64%) because audit fees were not included in the prior budget line. Legal fees increased \$5k (14%) due to increased fees for personnel issues. Payroll service decreased \$1,500 (33%) and Other professional decreased \$500 (10%) based on actual. Operational fringe benefits increased \$114k (13%) due to increase in health insurance. Fire Marshall increases in Dues & Subscriptions \$275 (10%) Computer & Software \$1,200 (14.5%) and fire prevention materials \$500 (11%) are all due to anticipated costs based on quotes. The fire marshall vehicle stipend was reduced to -0- because it was moved to the stipends on Salary & Benefit schedule. EMS decreases in R&M Equip \$500 (25%) R&M Bldg \$2k (50%) medical supplies \$2k (19%), telephone/WiFi \$3k (54.5%), training & Educ \$1,500 (30%) and uniforms \$1,200 (23%) are based on actual and anticipated costs. EMS increases in R&M vehicles \$1k (33%) for aging fleet of ambulances, and utilities \$4k (50%) based on actual, and Other equipment \$500 (100%) based on anticipated cost. Fire division increase in hydrant rentals \$6,225 (12.5%) and uniforms \$1,400 (28%) are based on actual and Dues & Subscriptions of \$5k (100%) is for I Am Responding software. EMS Nonbondables decrease in gas meters, appliances, and AC/Compressor upgrades were all reduced to -0- based on need and Building improvements increased \$20k for EMS station kitchen update. SCBA's increased \$4,200 (100%) in order to replace expired tanks, and extrication tools increased \$3,924 (11%) based on replacement equipment quotes received. Salary & Wages offset with appropriations decreased \$8,390 (23%) based on anticipated revenue. Capital appropriations increased \$300k (66.7%) due to \$100k needed for a new chief's vehicle, as the current vehicle body/frame is rusted out, and a \$200k increase in capital reserve based on apparatus replacement scheduled in future.
