TREASURERS' REPORT: Motion was made by Christopher Chaney and seconded by Don Robbins to approve treasurers' report. Motion carried with all ayes.

OLD BUSINESS: The following were discussed:

- Mr. Braslow advised the board that he met with the board of elections regarding election dates. Discussion held
- 307- Quotes received, multiple options discussed regarding repairs. Ambulance was hit while at the paint shop was sent to body shop and repaired. Jodi stated that Commissioner Gindlesperger was aware and authorized the repairs. Jodi and Rick did not find out until complete, as the shop was advised not to mention. Board did not know that this incident had occurred.

Kevin states that he was included in the meetings at times, was not involved in picking up the ambulance, was asked if we should just pick up and fix ourselves. - 55+ has been started, condos on Evergreen have not been approved by township yet. Need to have a meeting with the builder, Chief, EMS Captain and Fire Captain.
